Administration Rules...

15. Bermuda shorts may be worn to Sunday and holiday breakfasts and to breakfast and lunch during the final examination period. Skirts shall be worn at all other meals and at all times on the hill.

The present dress policy for normal meals in the dining halls is that skirts be worn except for "sunday breakfasts and mippers, and holiday breakfasts and lunches..." There have been suggestions that changes be made in this policy. The Rules

Dress at Jackson

Development of Dress Code

1950- Jackson Student Council creates recommendations for wearing dungarees

1952 - Dean Bush will not make a specific rule on dungarees, but requests students consider suitability of dress

1955 - Jackson Student Council makes restrictions regarding slacks and Bermudas during finals, approved by Dean Bush

1956- First official rule regarding dress appears in the Jackson College Handbook

1957 - Restrictions on wearing Bermudas expanded

1958- Handbook includes a section on dress in dining halls

Skirts must be worn at all times except for Sunday breakfasts and suppers, and holiday breakfasts and lunches and breakfasts and lunches during final examination period.

Slippers are never allowed in the dining room.

Girls may come to Friday and Saturday night suppers with their hair set, provided they wear a scarf or some other covering over their hair.

On faculty night girls are expected to wear stockings to dinner.

Phase One of Reform-Institutional Appeals



1960- Request for slacks to be allowed in dining halls on Saturday

1961 - Another request for slacks to be allowed in dining halls on Saturday

1962 - Third request regarding slacks on Saturdays

Request for clarification regarding wearing slacks during inclement weather

Student referendum regarding opinions on dress policy


Phase Two of Reform- Need for Autonomy

1964- Students want to be allowed to decide on an individual basis if the weather warrants wearing slacks

Dean Herrick does not want to give the JSC more power

"If the Dean wants to present an image of Jackson College which is not what we feel is Jackson College, we have to act."

1965 - "In such areas as personal dress... a girl should be given the right to make her own choices as part of her maturation through experimentation."

Phase Three of Reform- Move Towards Abolition


1966 - Jackson Student Council reconvenes in December

1967 - Jackson Self Study Committee announces students should control dress code
Betty Bone becomes Dean of Jackson College

1968 - Council discusses revising the dress code

Vote to abolish the dress code, include suggestions of what is considered "good taste in dress"

Dean Chayes works with Jackson students to end *in loco parentis* double standards
