SMOKING ORDINANCE REFERENDUM DRIVE

. ACTIVITY UPDATE

For your information, we have prepared this memorandum which outlines our recent efforts and plans for work to be completed on behalf of the Concerned Citizens Against Government Intrusion (CCAGI). As you know, we have been working with David Jenkins and our activities have included/will include:

Endorsement Gathering

We have contacted many labor leaders, minority leaders, _public affairs experts and other community leaders to secure their endorsement of the effort to repeal the smoking ordinance. While most people have preferred to remain neutral until the referendum officially qualifies for the ballot, we have enlisted the support of a number of Manager community leaders. We have attached a list of endorsers to date and will supplement it as more endorsements come in.

As you know, the San Francisco Labor Council is on record in support of our referendum drive and a letter was sent out last week to all of its member unions. We have followed-up on that letter with calls and visits to the larger and most politically organized of the affiliates. We have met with leaders and distributed petitions at a number of union halls. (A list of these unions is attached to this memorandum.)

In addition, we have arranged to speak on behalf of CCAGI a number of union meetings this week including the ____ _____ Warehousemen's Union and the San Francisco Building and Construction Trades Council.

We will continue this week to work with the labor community and will collect any petitions which result from our efforts for delivery by Thursday afternoon, June 30.

3. Minority Organizing

We are in contact with leaders inthe Asian, Hispanic and Black communities in efforts to secure some support. We have had limited success to date as most people are declining to take a position on the issue at this point. We will continue our efforts in this area during the week.

4. Signature Validity Checking

Last week we were asked to conduct a spot check of signatures which have been gathered. We have contacted Tom Bader for this purpose but have not yet been able to schedule a time and place. We will talk with Tom again today.

5. Press Conference

We have talked with David about putting on a press conference when the signatures are turned into the Registrar's Office this Friday, July 1. We spoke with Jim Foster about this and with Jack Crowley, both of whom are willing to participate. We can recruit a couple of other participants (possibly Sandy Taylor of EF Hutton and Gerson Bakar), draft releases and statements, prepare a press list, make press calls and otherwise work to put on the press event. Please let us know what part or parts of this event you would like us to handle.
