As you know, during previous efforts to generate labor opposition to federal workplace smoking restrictions, the American Federation of Government Employees (AFGE) has been firmly on the fence, at times sending representatives to testify on both sides of the issue.

AFGE, of course, also negotiated a compromise with the General Services Administration on its workplace smoking regulations, ultimately agreeing to the restrictions in return for what it believed to be a commitment from GSA to conduct comprehensive indoor air quality testing.

New leadership that took over at AFGE late last year has been receptive to labor's arguments against workplace restrictions. One indication of this new receptivity is a March 1 indoor air quality conference, sponsored by a Safe Workplace Air Coalition -- AFGE and the National Energy Management Institute -- and a follow-up March 2 news conference.

More than 125 federal and D.C. union officials attended the conference, with presentations by organizations and individuals such as ACVA and NEMI.

The March 2 news conference, at which AFGE released preliminary results of a survey of workers at several federal and D.C. worksites, was covered extensively in the local media, including AP and UPI, the Washington Post and Washington Times, and a number of local television and radio stations.

We believe AFGE's increasing interest in this issue marks a big step forward in our efforts to generate support from this key union on a variety of workplace concerns.
