PUBLIC SMOKING ISSUE

Overview

In September, TI staff continued to work on public smoking projects including revisions to the Corporate Assistance Program materials and preparation of allies responses to the OSHA RFI.

Highlights

TI staff met with Professor Amitai Etzioni to discuss progress on Phase I of the Center for Policy Research's (CPR) project, "Extreme and Moderate Responses to Exercise of Individual Rights." The CPR undertaking, sponsored by the National Chamber Foundation, will examine the "continuum of [the public's] responses, from mild disapproval to violence" to a variety of issues and behaviors, including smoking, animal rights, weight and environment. CPR also is preparing a cross-cultural analysis focusing on social issues in another society, such as Japan.

Staff is working to reschedule the visits with airport executives in Hartford, CT, Burlington, VT, Boston, MA, Portland and Bangor, ME, that were postponed in August at the request of the SAD staff.

John Fox made Americans with Disabilities Act and workers' compensation presentations to the Washington State Self-Insurance Association and the California Firefighters Association.

The National Energy Management Institute (NEMI) conducted indoor air quality contractor training sessions in three Texas cities, San Antonio, Beaumont and Houston, and in Philadelphia, Pennsylvania.

Representatives from the Labor Management Committee (LMC) and NEMI gave an indoor air quality (IAQ) presentation at the Florida AFL-CIO convention as part of a workshop on labor legislation. The convention subsequently approved an IAQ resolution.

Corporate/Smoker Assistance

The Tobacco Institute received approximately 102 requests for workplace smoking assistance and materials during September. Eighteen packets of materials were handled by TI staff and 80 were sent to TI's mail house service for fulfillment. Staff also

FIRE SAFETY ISSUE August 1991

Overview

In August the fire safety issue staff kept busy building and strengthening The Institute's relationships with key fire service officials and organizations. We also helped the fire service learn about its obligations under the Americans With Disabilities Act, and we continued development of a 1992 budget.

Highlights

The \$1 million funding for "fire-safe" cigarette research was deleted from the Consumer Product Safety Commission's (CPSC) 1992 budget request by the Senate appropriations subcommittee overseeing the CPSC. Federal Relations offered TI's assistance in restoring the funding (which had been approved by the House), and were told that Rep. Moakley was confident the funding would be restored. We kept our fire service allies informed.

An article by consulting attorney John Fox called "Will the Americans With Disabilities Act Change Fire Service Standards?" appeared in the August issue of <u>Fire Engineering</u> magazine. The article has prompted scores of requests from fire department officials for more information. Fox also will speak on the ADA at the annual meeting of the California State Firemen's Association.

We met with the president of the Call-Volunteer Firefighters Association of Massachusetts and the chairman of the National Volunteer Fire Council (NVFC) to discuss the goals of the new state volunteer organization, how the association can be an effective member of the NVFC and assistance available through The Institute's Fire Safety Education Program.

The Consumer Awareness Committee of the CPSC's National Smoke Detector Project met in Washington, D.C. Committee members determined an action plan for the coming year, and divided responsibilities. As a member of the committee, we volunteered to help draft a standard speech for project representatives to use when encouraging organizations to become involved in the project.

TI consultant Phil Schaenman discussed industry-sponsored research on international comparisons in fire protection with the staffs of the Congressional Fire Services Institute (CFSI) and Rep. Curt Weldon (R-PA). CFSI staff requested additional copies of all four TI-sponsored TriData reports.

TriData staff gave a presentation on the <u>Proving Public Fire</u> <u>Education Works</u> report at the annual meeting of the Virginia State Firemen's Association.

We assisted in designing a brochure publicizing the critical incident stress debriefing team hot line of the American Critical Incident Stress Foundation. The NVFC Foundation, on whose board of directors TI sits, is funding the hot line in its first year. We also assisted the NVFC in updating its membership brochure.

In response to a number of requests from newly appointed statelevel public fire educators for help with resources and ideas, we began compiling a list of state fire marshals' offices that employ state-level educators in hopes of developing a peer networking directory. The National Association of State Fire Marshals is assisting.

In August, TI's Fire Safety Education Program responded to 50 requests for information and educational resources from fire departments and organizations in 23 states. In addition, the Congressional Fire Services Institute staff was grateful to receive a "grant" of several used office chairs from TI.

We provided a briefing on the "fire-safe" cigarette issue and TI's grants program to a new attorney for Lorillard.

We computed 1991 estimates for the fire safety issue budget, and submitted initial and revised budget requests for 1992.

Sharon Ransome continued to learn and rehearse the standard presentation on The Institute's Fire Safety Education Program and the "fire-safe" cigarette issue. We should begin receiving requests for 1992 fire conference speaking engagements before year's end.

We met with a new consultant working with the joint venture group of company scientists on the "fire-safe" cigarette issue to explain TI's Fire Safety Education Program and our work with the fire service.

We completed an updated draft of the "Accidental Fires: Where The Tobacco Institute Stands" brochure. Budget concerns have put production of the revised brochure on hold for now.

We met with the public education coordinator of the Prince George's County, Maryland, Fire Department about a proposal to produce the video featuring TI's Fire Safety Education Program Fire Safety Issue--August Status Report Page 3

materials and other free public fire education resources. Meanwhile, we worked on developing a draft script.

We began a discussion with "social costs" issue staff about the social costs aspects of the "fire-safe" cigarette issue. We will consider whether and to what extend The Institute's "social costs" arguments are appropriate to advance within the context of federal "fire-safe" cigarette research. The CPSC is charged with developing information on the "societal costs of cigarette-ignited fires."

SOCIAL COSTS

Primary Responsibility: Calvin H. George Carol Hrycaj

Overview

In August, issues staff completed a second draft of the 1992 Social Costs budget and 1991 spending estimates, which hold projected expenditures to approximately half of the original 1991 budget for this issue area in order to cover unanticipated cost overruns in other issue areas. As a result, activities in this issue area are being held to a minimum.

Highlights

An edited draft of "The Political Element in Science: SAMMEC and the Anti-Smoking Lobby," an in-depth examination of the statistical methodology underlying "social costs" figures promulgated by the U.S. Department of Health and Human Services, has been returned to the authors for revision and clarification. Consulting economists Robert Ekelund and Richard Ault are expected to provide their second draft in early September. At that time legal review of the document will be undertaken.

In addition, issues staff will work with consultants to develop an executive summary of the Ekelund and Ault study for broad distribution to the media and policymakers. A promotion plan, including the potential for op-ed pieces and letters-to-theeditor in selected media markets will also be developed.

OVERVIEW
