**WHO INSPIRED YOU?**

What makes a great university? Lawrence Bacow, president of Tufts University, is fond of saying that it is outstanding faculty and excellent students. Both elements have been in plentiful supply over the 25-year history of Tufts Veterinary School.

While the quality of the curriculum speaks for itself, it's the students who are often the source of eloquent tributes to the faculty who taught them and made a lasting impression on their lives. When we asked, "Who inspired you?" the following Tufts alumni were enthusiastic about faculty members who made their veterinary school experience great. While working in the blood bank in 1993, Dr. Julie Kopser, V93, recounted how she had the opportunity to see **Dr. John Rush** with several others, resuscitate a dog with open cardiac massage. "When I had the chance to apply for a National Institute of Health summer research grant, Dr. Rush was kind enough to offer me a project. Once I saw the first echocardiogram, I was hooked on cardiology! Despite his many responsibilities, he gave me the time and guidance I needed to complete a research project and

present it at the ACVIM (American College of Veterinary Internal Medicine) the next year. The cardiology, ultrasound and critical care knowledge that I gained peripherally while working on that project formed the core upon which I built the rest of my education. I am now able to use these valuable ultrasound and echocardiography skills in private practice to increase the quality of care that our practice can offer."

**Dr. Susan Cotter** was cited by Dr. Gary Weitzman, V89, as "an outstanding teacher, clinician and mentor; a true role model."

Dr. Lori B. Kreidberg, V88, remembers Dr. Cotter from the perspectives of a student and client. "While in my senior year, my geriatric cat developed lymphoma. Dr. Cotter's practical, genius approach to my cat's cancer taught me so much about veterinary medicine, client relations, patient care and gave my cat one more year of quality life!"

Dr. Susan Pincus (formerly Rohrbach), V95, notes that **Dr. Mark Pokras, V84**, was "a great teacher, great researcher. He taught me that nothing should stop you from doing what you want to do. He has been an inspiration throughout my career." **Dr. Pokras** also inspired Dr. Kathryn M. McGonigle, V02, who wrote: "As a professor, advisor and trusted friend, Mark Pokras constantly sought the best for all his students."

He encouraged and challenged us, making sure we had the skills we needed to be successful and confident veterinarians, while having lots of fun. What a wonderful difference he made in my education!"

**Dr. James Ross** was commended by Dr. Robert Marini, V84, and Dr. Tami Morgan, V94. "He was always 'on,' always enthusiastic about knowledge and the intellectual life, and tireless in his teaching...and he can really dance," said Dr. Marini. Added Dr. Morgan: "I would never have made it through school without his personal attention to me and my education. He was always there to reassure me that the hard, long road would pay off. Thank you, Dr. Ross, for being there for me!"

Dr. Cristina Sanz-Valas, V93, remembered **Dr. Mary Rose Paradis**. "From my first meeting at my interview at Tufts, I felt drawn to her caring attitude. When the foal I worked hard to keep alive for two weeks, aspirated a feeding given by someone else due to my being late that morning, she felt and understood my pain. Her support was quiet, but tremendous and even though I was a small animal student, she always greeted me by name. She is just awesome!"

Dr. Katherine Bergen Pierce, V98, noted that **Dr. Henry Childers** "was my mentor in the first Problem-Based Learning session. He was kind, thoughtful and always enthusiastic about learning. His energy and commitment to veterinary medicine was so inspiring. I will never forget how he quietly and kindly questioned my attempt to convince my fellow PBL members that "stomatitis" was not "inflammation of the stomach!"

Dr. Jane Linden, V99, cited **Dr. Orla Mahony**. "Not only was Orla an exceptionally knowledgeable and professional doctor, she was also a caring and compassionate person towards owners and their pets. She modeled the kind of veterinarian I wanted to be for my clients. She also had an excellent sense of humor which was always useful during times of stress and anxiety which new fourth-year students commonly have."

Dr. Linda Frank, V85, remembered that, "At graduation, I introduced **Dr. Charles Sedgwick** to my family. He said, 'It's Charles or Charlie, we're colleagues now.' I will never forget that and always appreciate how that made me feel. I continue to use that same approach with students that I teach."

Dr. Tracy A. Carreiro (formerly D'Allesandro), V84, praised both **Dr. Elizabeth Lawrence** and **Dr. Linda Ross**. "Dr. Lawrence was the first person to awaken me to the importance of the human-animal bond. This has

been critical in my development as a veterinarian. Her intelligent, caring demeanor made her a powerful role model for me. Dr. Ross taught me to think logically and critically about the signs and diagnostic test results of each case. This stays with me every day."

Dr. Cathy Findlen Gajewski, V93, recognized **Dr. Al Sollod**. "He helped facilitate numerous important events in my life as a member of the international club and because of him and his office I had experiences in Pakistan and Kenya that I will never forget. His limitless enthusiasm and ability to push, prod and meddle will forever be appreciated."

Dr. Caroline Heller, V98, commended **Dr. Howard Levine**. "Dr. Levine was my mentor for my four years at Tufts. He was one of the best. He was always available for questions, always a wealth of good advice, and always a positive influence. I was lucky to have him as a mentor."

## **T** USVM RECEIVES \$25 MILLION NIH CONTRACT

---

Tufts has been awarded a \$25 million seven-year government contract from the National Institutes of Health (NIH) to study diseases that could pollute the nation's food and water supply in a bioterrorism attack. The grant will support the establishment of a Microbiology Research Unit within NIH's new nationwide Food and Waterborne Disease Integrated Research Network. Tuft researchers will work with the University of Massachusetts research team to develop the Center of Botulinum Therapies Research and Development, which will focus on the diagnosis and treatment of botulism poisoning, a dangerous bioterrorism threat. Dr. Saul Tzipori, Distinguished Professor and Head of the Division of Infectious Diseases in the Department of Biomedical Sciences, will lead the research initiative. Tzipori's success in attracting this award clearly positions Tufts at the forefront of the national biodefense effort and enhances the School's growing reputation as a major biomedical research leader.

## TUSVM RECEIVES LARGEST GIFT

Tufts overseer, Agnes Varis, has made a \$5,000,000 gift to support TUSVM's groundbreaking research in biomedical sciences. The gift will be used to stimulate research collaboration across the University in comparative biomedical sciences and public health. Additionally, it will support the growth of graduate education programs to complement TUSVM's world-class research program in comparative biomedical sciences.

Varis' leadership support has been instrumental in bringing about numerous improvements to TUSVM. Her donations include the Agnes Varis Chair in Science and Society, the Agnes Varis Lecture Hall, and the Agnes Varis Cat Ward within the Henry and Lois Foster Hospital for Small Animals. This most recent gift was inspired by Varis' understanding of the importance of training veterinarians to meet critical national needs in biomedical research and public health.

Varis, a member of the Board of Veterinary Overseers since 1996, received an honorary doctorate in public service from Tufts in 2003. She is recognized as a pioneering leader in the pharmaceutical industry and is dedicated to increasing the accessibility and affordability of lifesaving drugs for people. Varis has worked tirelessly to raise awareness of science's responsibility to help society's problems. Her business and civic leadership is matched by her dedication to the arts and education, and by her love of animals - especially cats.

## RAY POWELL, V85, RECEIVES OUTSTANDING ALUMNUS AWARD

At Reunion & Comeback in September, 2003, the Tufts University Alumni Association honored Ray Powell, V85, as the Outstanding Alumnus for 2003. Steve Rowell, V83, commented, "Ray has shown himself as a person that veterinary medicine can be proud of. He is also one of those rare people that one might ask 'How did a veterinarian get involved in that?'"

"Ray served not only as a veterinarian, but he has held positions in public service as well. He has served as the president of the Western Land Commissioners Association and as the New Mexico Commissioner of Public Lands. As the New Mexico Land Commissioner, Ray was in charge of over 13 million acres of state land. Income from that land went to fund education and many other worthy programs in the state. Ray saw that the land produced money for many uses, but no one

was repaying the land. His vision, tenacity, and even audaciousness had him doing things that no Land Commissioner had dared to do before. He looked out for the land, he found ways to leverage the land into fruitful production by other means than raising cattle or extracting the natural resources. He truly has changed the way people think about land use in New Mexico and he has instituted programs and policies that will live on for many years.

Ray continues to practice veterinary medicine and he remains involved in areas that affect our profession. He recently jumped into being on the New Mexico state board in veterinary medicine. When the Los Alamos area burned a few years ago,

Ray coordinated efforts with local veterinarians to create shelters for the many displaced animals – pets and wildlife and helped avoid additional catastrophe. He has helped create programs to educate children on the importance of the land and animals around us. He promotes education to foster growth of people that care about one another, and this planet we inhabit with other animal and plant species."

## RENOVATED HENRY & LOIS FOSTER HOSPITAL FOR SMALL ANIMALS REDEDICATED

On November 1, 2003, Overseers, Trustees, faculty, staff and friends joined together for the dedication of the newly renovated Henry and Lois Foster Hospital for Small Animals. The \$3.25 million renovation undertaken over the past 18 months included a 20% expansion of space that includes a new emergency room and trauma center, a more spacious intensive care unit, and new hospital wards and treatment areas. Tufts now treats more than 22,000 animals a year at the Foster Hospital for Small Animals, nearly double the case load the Hospital could manage when it opened in 1985. The Foster Hospital for Small Animals continues to garner international attention for its leadership in veterinary specialties such as emergency and critical care medicine, oncology, diagnostic imaging, surgery, nutrition and behavior.

At the International Veterinary Emergency and Critical Care Symposium in New Orleans, **Dr. Lisa Freeman, J86, V91, N96**, and **Dr. Kathryn Michel, V83**, shared the honors of receiving the annual American College of Veterinary Emergency and Critical Care Scientific Achievement Award. The award recognized the duo for their outstanding contributions to clinical nutrition through research, teaching, publishing, and other scholarly activities. Congratulations!

**Ann Basatto** has returned to Tufts! Ann will be working as a technologist in the pathology laboratory. Ann worked in the hematology/chemistry section of the Tufts Veterinary Diagnostic Lab for 10 years and remained with the lab when it was purchased by IDEXX.

**Dr. Charles Shoemaker** joined the Department of Biomedical Sciences as a Research Professor in August 2003. He received his PhD degree in Biochemistry from the University of Iowa in 1979. Following his post-doctoral fellowship under the supervision of Nobel Laureate, Dr. David Baltimore, and then as one of the original scientists to start up Genetics Institute (1981-1978), he was appointed Assistant Professor in the Department of Tropical Public Health, Harvard School of Public Health. He was promoted to Associate Professor in 1996. He has been at AgResearch Ltd., a New Zealand owned life sciences company, since 1997 while maintaining an adjunct Associate Professor appointment at Harvard University, Department of Immunology and Infectious Diseases. He has been leading the Animal Health Platform of AgResearch Ltd. since 1999. His expertise in the molecular biology and immunology of helminthes complements our current expertise on cryptosporidiosis and microsporidiosis.

**Dr. Patrick Skelley** joined the Department of Biomedical Sciences as Assistant Professor in August. He received his PhD degree from the Australian National University, Canberra, Australia in 1986. Following his post-doctoral fellowship and research fellowship he joined the Department of Tropical Public Health, Harvard School of Public Health, where he also served as an Instructor. He is well known for his studies on schistosome glucose transport protein and his research is supported by grants from NIH and WHO. He also has extensive teaching experience and will be a valuable asset to TUSVM's infectious diseases teaching program.

## ON CAMPUS NEWS

### **Dr. Henry Foster Honored**

The Massachusetts Society for Medical Research celebrated its 50th anniversary and honored Tufts Veterinary School honorary alumnus, Tufts University Trustee Emeritus, chair of the Veterinary Board of Overseers, **Dr. Henry L. Foster**. TUSVM was delighted that a prominent member of the TUSVM community was recognized for his leadership in biomedical research.

### **Curriculum Changes**

The Executive Faculty Board approved the following recommendations of the Curriculum Committee which went into effect this academic year:

*1st and 2nd Year:* The Cell and Tissue Biology Course was dismantled and a Veterinary Histology Course was constructed from parts of Cell and Tissue Biology and Organology. Other molecular biology material was moved to the Biotechnology Course which was moved from the 2nd year to the 1st year, 2nd semester. Ten hours were added to the Histology Course to include organs of special senses and the brain.

*2nd Year Farm Rotation:* Eliminated the Fall Semester half day and changed the Spring sessions to 7 a.m.-12 p.m.

*4th Year Rotations:* Practice Environments Rotation can now be accomplished any time during the 4th year curriculum. The Subspecialty Core rotation was increased from 3 to 4 weeks (Subspecialties include Oncology, Neurology, Cardiology, Ophthalmology, and Dermatology). The Curricular Mission Statement was adopted to guide further changes, as the curriculum continues to be reviewed:

*The mission of the TUSVM curriculum is to prepare graduates for entry level practice in any of the major domestic species, provide exposure to the innovative TUSVM Signature Programs, and provide enough flexibility and access to resources to allow TUSVM students to pursue non-practice or non-traditional practice careers (such as public health, wildlife, international veterinary medicine and biomedical research). The curriculum is designed to nurture students who will become leaders in developing the science, technology and ethics that will shape veterinary practice in the future and to foster students to become life long learners.*

### **Spay/Neuter Clinic On-Site at TUSVM**

On September 7, TUSVM dedicated the Luke & Lily Lerner Spay/Neuter Clinic. This clinic is located in the basement of the Henry & Lois Foster Hospital for Small Animals. This facility will contribute to TUSVM's surgical training program as well as to community efforts to reduce companion animal overpopulation. The new clinic will free up the hospital surgical suites and will keep shelter animals separate from hospital client animals.

### **Student Statistics**

Dr. Angie Warner reported the summary results of TUSVM students who took the North American Veterinary Licensing Examination in Nov.-Dec. 2002; TUSVM students had a 98% pass rate and scored above the national mean for number of correct responses in all categories!

83 members of the Class of 2007 were welcomed to campus this fall. Ten new interns and 12 residents also began their clinical training programs this past summer while nine new students began the M.S. in Animals and Public Policy and three students enrolled this past fall in the new PhD program in Comparative Biomedical Sciences.

**Wendy Ernst, V01**, reports that she got married on June 28, 2003 to DJ Fowler.

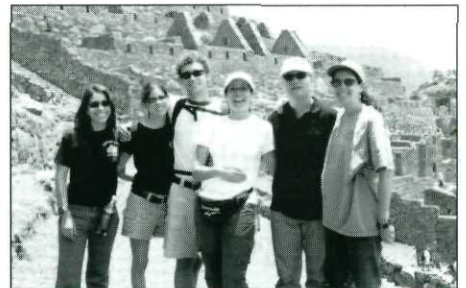

Director of the Wildlife Clinic **Mark Pokras, V84**, was interviewed by the *Worcester Telegram & Gazette* regarding the deaths of geese found at Elm Park in Worcester (September 3, 2003).
