

**AGREEMENT BETWEEN**  
**THE REPUBLIC OF SUDAN AND THE REPUBLIC OF SOUTH SUDAN**

**ON**  
**BORDER MONITORING SUPPORT MISSION**

**KADUGLI, SUDAN - 08 AUGUST 2011**

**Background**

1. The committee comprising of SAF representatives, SPLA representatives and the Force Commander (UNISFA), reaffirmed their commitment to the agreements signed in Addis Ababa on 29 June 2011 and 30 July 2011, which relates to the draft agenda as given in Para 4 of the agreement signed on 30 July 2011 to undertake a joint assessment mission to establish; the location of the mission headquarters; location and number of sector headquarters; location and number of teams; and the personnel to be assigned to these tasks.

**Points of Agreement**

2. The Parties agreed to the following:

**Location and Number of Sector Headquarters.**

- a. The Parties agreed to the mission having four Sectors and their Sector Headquarters location as follows:
  - i. Sector 1 - Renk.
  - ii. Sector 2 - Kadugli.
  - iii. Sector 3 - Aweil.
  - iv. Sector 4 - Raja.


**Joint Reconnaissance Mission**








**ATTACHMENT TO THE AGREEMENT BETWEEN**  
**THE REPUBLIC OF SUDAN AND THE REPUBLIC OF SOUTH SUDAN**  
**SIGNED ON 08 AUGUST 2011 ON BORDER MONITORING SUPPORT MISSION**

1. A committee comprising of SAF representatives, SPLA representatives and the Force Commander (UNISFA), undertook a joint reconnaissance mission from 09 –11 August 2011, following locations were visited / over flown during the reconnaissance :-
  - i. Kadugli – Ar Rank – Paloich – Kaka – Malakal.
  - ii. Malakal – Bentiu – Tharjath – Mayom – Aweil – Raja.
  - iii. Raja – Boromedina – Firka – Timsaha – Raja – Abyei - Kadugli.
2. The joint committee reassembled on 12 August 2011, to review the points of disagreement; however parties' maintained status quo on their previous positions as agreed on 08 August 2011.
3. The report by UNISFA FC on the outcome of his reconnaissance mission on operational requirements (including areas of disagreement) will be submitted to the JPSM on 17 August 2011 after consultation with the Parties, as per the 30 July agreement.
