






Harrowing of Gwynedd

Just a few weeks ago Katherine Kurtz's new paperback hit the shelves. The Harrowing of Gwynedd is the first book of Kurtz's fourth trilogy chronicling the history of a pseudo-Wales. The series, now ten novels and a collection of short stories, describes the interracial wars between the "normal" humans and the Deryni

The world of Gwynedd is a typical medieval fantasy realm. Its history diverges from that of our own when what some have called the greatest tragedy in Western history was averted: Charles Martel was never born. When the Moorish invasion reaches England, a Welsh prince, St. Haldane, unites the principalities and halts the incursion. Centuries later a coup against Haldane's successors places a despotic Deryni regime on the throne. After generations of oppression, St. Camber, a Deryni magician, leads a restoration movement which restores the human Haldane heir to the throne.

The novel opens some twenty years after the reformation. St. Camber and other heroes of the restoration have died. The king is dead and the land is under the rule of the regents of his young son. The trilogy is appropriately titled "The Heirs of St. Camber" and tells of the struggle of the Deryni against the racism of the "backlash."

The human regents remember the Deryni as oppressors and not as liberators. After infiltrating the church, they have Camber's sainthood revoked, his follow-

ers are declared heretics, and his race demon-spawn. Then the church and regency join forces to wage a war of geno-

The novel tells of the valiant struggles of a small group of Deryni scholars to counter the violence of the so-called "scourge of God." The group finds a solution. Through an esoteric magic ritual, the Deryni may become human. The novel examines the dilemma they face. Is any degree of safety worth the rejection of heritage?

Against this conflict Kurtz tells the story of a budding prince. The crippled younger twin of the king, he is slowly developing the Deryni-like powers that are the legacy of his Haldane ancestry. The prince must unite his duty as heir, his inclination toward the priesthood, and his growing ties to the Deryni underground into one goal. Ultimately, he must join the powers of church and crown in an effort to change them from within.

Kurtz once again shows her amazing power with allegory in bringing these important issues to popular literature. One wonders why her works are not stocked on our Diversity bookshelf. Perhaps it's because it is about a truly courageous group of people peacefully working against racism and genocide rather than a peuling mob whining about nearly nonexistent prejudice. This moving drama of racism and sacrifice should be required reading for all Tufts students.

The Real El Salvador

Dialogue in El Salvador has come to a dead end. It is always the same story, human rights violations by the FMLN and death squads, repressive government, guerrilla insurrection,

and so on. When is this going to end? There has to be a solution. Maybe we can find it by looking back at the decade before the Civil War that began in 1979? But let's look at El Salvador from a different angle, from an economic point of view. I know the word economics is typically taboo for most political ideologues, but how can they pass judgment on what is best for the country without knowing the hard economic facts?

There is no doubt that the fundamental causes of El Salvador's civil war are poverty, injustice and inequality. Yet was it the decline in economic conditions before 1979 that demanded social change? After I answer this question, I will suggest the road which El Salvador should try to take from now on

In general, the economy was doing extremely well. From 1969 to 1978 the economy grew at an average rate of five percent per annum. Even though this is not impressive for a third world nation, it is still satisfactory. The annual growth rate for all Latin American countries was six percent over the same period and even though El Salvador's growth was below the average, it would be wrong to say that conditions were worsening.

Yes, a positive growth rate is great, but what does that tell us about what is really important-the economic conditions of the people, especially the poor? Thus, it is important to look at food production, wages, and the growth of sectors that provide employment.

Food production is especially important to a country like El Salvador, considering the production of beans, rice, and corn, the three major staples that feed the poor. The production of these staples increased dramatically in the years 1969 to 1979. Bean production increased by sixty-six percent, rice by forty-two percent and corn by eighty-one percent. All three exceeded population growth which was about thirty-nine percent in this decade. Thus it is easy to deduce that the poor were eating much better in 1979 than 1969.

The small manufacturing sector in El Salvador was growing rapidly since the 1950's, mostly due to the creation of the Central American Common Market. Up to 1976, manufacturing output had increased from 14.7 percent of the Gross Domestic Product to 19.7 percent in 1977, which had the effect of creating more jobs. However, manufacturing output declined from 1977 as a result of increasing violence and the destruction of factories by the guerrillas, the kidnappings of key executives, and capital flight because of

financial insecurity. One does not have to be an economist to realize that the decline in manufacturing after 1977 was the result of the violence, not the cause.

Wages are also very important to consider to assess social welfare. Wages increased in nominal terms, yet because of inflation, real wages actually decreased in the decade before the war. Even though there was a ninety-one percent wage increase before the war, the inflation rate of 102 percent bit into the purchasing power of the workers. This points to a decline in the welfare of urban workers.

In rural areas, the wages of rural workers increased by ninety percent for men and 109 percent for women. Taking into account the inflation rate, men's real wages decreased and women's real wages increased somewhat. However for agricultural workers, one must take into account that they do not spend money on food because the farm provides it for them. Thus, the repercussions of a cut in wages in real terms affected more urban workers than agricultural workers.

It is most people's impression and initially mine that the quality of life must have been plummeting during the period before 1978, but actually it wasn't. Life expectancy grew from fifty-four years to sixty-three years. Life expectancy increased more than six years in only one other Latin American country. There was also a decline in the death rate of about 30.3 percent and a dramatic reduction in infant mortality, from 63.5 percent in to 50.3 percent in 1978. Literacy also improved by 1978, from forty-nine percent in 1969 to sixty-two percent in 1978.

What is most surprising is the evidence that in this decade there was actually a reduction in income inequality. (Sorry Latin American Collective, and by the way the notion of fourteen families in control of the country is a myth). For example, in 1969, the richest twenty percent of households in El Salvador received fifty-two percent of the country's total income. From 1961 to 1969, the annual rate of growth of income of the richest twenty percent was four percent a year. while the middle forty percent increased at 10.5 percent and even the poorest forty percent at 5.4 percent. The income inequality gap was inarguably narrowing, and it did continue to narrow in the 1970's. The last statistic, according to the World Development Report of 1989, estimates that the highest twenty percent of the population in 1977 had 47.3 percent of total income. Even though this figure is high, when compared to other Latin American countries it is lower. For example Mexico's richest twenty percent held 56.1% of income in 1977, Peru's richest had 60.5 percent in 1972 and even Costa Rica's richest twenty percent had 54.8 percent of the country's total income.

Furthermore, improvements in social welfare were due to government policy. Expenditures on public health during 1970's averaged about 14.8 percent of the total budget, which is the third highest percentage of the nineteen Latin American countries. Expenditures on education were 27.4 percent of the budget which was the fifth highest percentage of the nineteen Latin American countries.


In view of this, it is obvious that economic conditions were improving before the war. Even though real wages decreased, all other economic indicators, especially those of food production, spending on public health, infant mortality, death rates, and income distribution show that Salvadorans did enjoy some increase in welfare. Improvements in the indicators mentioned above cannot happen without a simultaneous improvement in the living standards.

So what happened? If economic conditions were improving, why resort to war? The problem was that things were not happening fast enough. Furthermore, the standard of living is sometimes so low that these substantial gains in welfare are not enough.

However, El Salvador was making progress, even though the 1970's were hard years for the world economy. The economy still continued to grow despite the two oil shocks which were so detrimental to the Salvadoran economy. Other exogenous factors included the interruption of trade with Honduras in 1975 as well as the return of 100,000 Salvadorans from Honduras. In addition, the population growth of El Salvador aggravates the situation. It grew from about 3.2 million in 1968 to about 4.4 million in 1978 and is now estimated at about five million. El Salvador's area is about 21,000 square kilometers, making it one of the most densely populated countries in the world. Analyzing these factors, El Salvador was lucky not to experience a decline in social welfare in the decade before the war.

Unfortunately, the war did happen and still continues, and the welfare of the people has never been worse. Welfare spending in 1980 had gone down to 4.7 percent of the national budget and spending on education had decreased to 17.1 percent. This is due to the increase in spending for defense which grew from 6.6

Nicaraguan Quagmire

The revolutionary Sandinistas, promising democratic reform, re-establishment of basic rights, and freedom from oppression for all Nicaraguans, enjoyed the active support of the United States as they fought against the dictatorial Somoza regime. But as the revolutionary dust cleared, the Sandinista regime's promises were thrown aside as the government engulfed itself promoting communist insurgents in neighboring nations, discouraging opposition, and antagonizing the United States, a former ally. The United States was forced to support this totalitarian regime. As the injustices to the Nicaraguan people increased, the United States became more alienated by the government. The U.S. realized it could no longer support this oppressive government and still adhere to its democratic principles. As the resistance to the Sandinista administration consolidated, the democratic forces asked for U.S. support. The U.S. had to make a decision whether to continue the status quo which allowed the abuses to exist, or to aid the opposition movement which wanted to revive the original revolutionary ideology. After economic and diplomatic pressure failed, the U.S. was forced to support the Contra movement in hopes that it would put enough pressure on the government to reform its ways.

well-received by the U.S., our government disagreed with the new regime over the issue of military aid. During the first two years of the new government, the U.S. sent \$118 million in economic assistance to for the Sandinistas who also wanted mor arms from the U.S. Our refusal to send more arms to a country that after two years of civil war had been saturated with arms, was the watershed in the progressively more antagonistic relationship between Nicaragua and the U.S. The Sandinistas willing to lend military assistance to the region. The U.S. did offer to send military advisors and to allow a number a number of soldiers to train at a U.S. base in Panama, but the Nicaraguans refused. As the arms build-up continued, neighboring nations began to feel threatened. Costa Rica and Honduras became disillusioned with the Sandinista regime and withdrew their support. Various leaders that were part of the Sandinista regime; Chamorro, Robelo and Pastora, also realized the change that had subverted the revolutionary government and soon withdrew their support them. also. No longer was the Sandinista government attempting to fulfill its original human rights violations became a major platform, instead it was nurturing the same complaint on the Contra opposition as the seeds of destruction that had caused the down fall of the Somoza regime.

Nicaragua fed the opposition movement in El Salvador that was becoming increasingly hostile towards the legitimate existing government. The Salvadoran insurgency, FMLN, looked to the revolutions in China, Vietnam, Cuba and Nicaragua as examples to follow in order to bring about a communist coup. Nicaragua provided M-16 guns and other military equipment to the rebels, while also acting as a channel for Soviet weapons brought into El Salvador. Cuba also played a large role in supporting the insurgency of El Salvador. Training high ranking El Salvadoran military personnel was a major role for Nicaragua, not to mention encouraging and organizing guerrilla warfare for the FMLN to carry out against the government.

This hostility towards the Salvadoran

government was accompanied by hostility towards Honduras and Costa Rica. In Honduras, the Sandinistas supported terrorist acts carried out by a minor insurgency group. They also helped build a communist infrastructure with the help of Cuba which would be eventually used to overthrow the existing Honduran administration and replace it with a military communist regime. Nicaragua also trained members of the Revolutionary Front, a clandestine communist organization that has engaged in terrorist acts since 1980. The situation in Costa Rica was peculiar because this country, unlike many other Latin American nations, has had a long tradition of stable democratic governments. Despite this, the Nicaraguan Mission of aiding revolutionary movements in all of Central American included Costa Rica. Since 1981, Costa Rica has been the victim of terrorist acts that have been directly linked with the Nicaraguan Sandinista regime.

Thus, the U.S. is justified in supporting the Contra movement which hopes to topple the regime through democratic elections and end the encouragement and support by Nicaragua of revolutionary communist insurgents. It is worthwhile to remember that aid to the Contras was started a year and a half after Nicaragua began aiding the revolutionary insurgency in neighboring nations. A provision in the Organization of the American States (OAS) Charter Although the overthrow of Somoza was says that member nations may use force because "every act of aggression by a State against the sovereignty or political independence of an American State shall be considered an act of aggression against the other American States." Had the U.S. not given aid to the Contras, it would have allowed the aggression by the Sandinista regime to continue unchallenged, while allowing the destruction of the right of self-determination of the Nicaraguan people.

Every since President Carter, U.S. foreign aid has been linked to human rights. A country must prove its guarantee of turned to the Soviets who were more than human rights to its citizens before it can receive aid from the U.S. Such was the case in Nicaragua but, unfortunately, it became more difficult to prove that no human rights abuses were occurring. Aid to the Sandinistas was finally cut off when the transformation of the regime from a democratic revolution to a communist totalitarian regime became apparent. Aid to Nicaragua was also linked to an end to Nicaragua's support of anti-establishment movements abroad. As the news about Sandinista aid to El Salvador became public, a \$75 million aid package was denied

Although abuses exist on both sides, government implemented a state of siege. This included violently quieting all resistance. A token independent political party was established which served as the key to continued vital economic and political aid from the free world. The government also took over the Somoza newspaper Barricada and used it as a propaganda device, although about eighty percent of the population was illiterate. Miskito Indians in the region were rounded up and their homes destroyed. Employees at the U.S. embassy were humiliated as they were forced to answer questions about their involvement with the embassy. Some of them were strip searched and tortured.

Foreigners cannot obtain true numbers of the human rights abuses that go on in the nation because the country has been totally closed off to the world. Foreign reporting is obsolete. The United Nicaraguan Opposition (UNO), made up of vari-

rights violations.

Perhaps the greatest abuses were carried out against the Catholic Church which had influence over the majority of the population. The Church espouses the causes of liberty, democracy and human rights. This is the reason for increased hostility by the government. The regime tried to weaken the power of the Church by creating a Popular Church but little among the faithful has attached itself to it. Force has been repeatedly used to prevent the public from attending the Managuan Cardinal's masses. It has also deprived the Church of a means of communicating with its followers. Foreign priests were expelled, as well. After the March 22, 1985 announcement by Bishop Obando y Bravo of Managua for increasing dialogue between the factions, the Vatican elevated him to the position of the Cardinal which shows the Vatican's support of the Church and what it stands for in Nicaragua.

Not only has the Church expressed interest in creating some sort of dialogue between the sides but so has the Contra movement and the U.S. Immediately following the publicity of Sandinista aggression, the U.S. did not suddenly begin aiding the Contras, but rather, it tried other methods to encourage change. In February of 1985, the civil opposition proposed a plan calling for talks which was to be accompanied by the restoration of civil liberties, amnesty for political prisoners, and guaranteed safety for participation in

ous Contra groups and headed by Cruz, politics of the opposition. Later, the armed was formed to help put an end to human opposition announced another plan which was to be mediated by the Church which gave its support for the plan. President Reagan proclaimed his adherence to the plan and agreed to withdraw military support for the opposition of the Sandinistas accepted the restoration of human rights laid out in the original plan. The Nicaraguan government has made it clear that it does not want to reach reconciliation in dialogue, but rather, by violence. An economic embargo was also used by the U.S. to pressure the Sandinista regime to reform. This, too, failed to budge the regime.

Therefore, the U.S. government, in its attempts to adhere to democratic principles, was and is forced to support the armed opposition in Nicaragua. It does this because the Contra movement is promoting the ideology that proclaims liberty for all the Nicaraguan people to decide their destiny. They are not advocating structural change but are, rather, working within the limits of the present structure to re-establish the freedoms that have been denied the Nicaraguans by the Sandinista administration. The Nicaraguan armed resistance, fueled by the hope of prosperity for all, continues to struggle against extreme odds to challenge a dictatorial communist regime that refuses human rights to its citizens.

It is difficult to describe my emotions at the time of the presentation of that record. I felt both pity for the ignorance which was displayed and an urge to


break the record and shred the offender's throat with the shards. I constrained my emotions, merely commenting that this person was lucky I had such a broad ranging sense of humor.

Return to the Family

Over 2000 years ago a man had a vision of the perfect city-state. In this meritocracy there were perfectly equal opportunities for success. There was no sexism. Men and women fought side by side in battle and their only commitment in life was to the state. To ensure no favoritism in this meritocracy, children were taken from their mothers at birth and were placed in public daycare centers. To guarantee primary devotion to the state families did not exist. Men and women had sex with different partners at will. This was a perfectly efficient state envisioned by Socrates in the Republic.

As ugly and as distant as this world seems to us, if we replace the word 'state" with the words "wealth and independence", we describe an attractive ideal held today. In our age similar demands are being made in the name of wealth, independence, rights, and individual freedoms. These qualities, however necessary to man's well-being, have been expanded to a point at which it results in a solitude between men and women. We have witnessed a dramatic deterioration (some would say evolution), of the family unit, with marriage and child-rearing becoming second priorities to the individual ambitions of parents. A quick look at the most recent divorce statistics should provide some evidence of this. Marriage has become a matter of convenience, or inconvenience, and raising children has become as much the duty of babysitters and daycare centers as it is of the parents, if not more. At one time, a woman would have been ostracized for leaving her child in the care of someone else. Today, it is not only accepted, but it is widely encouraged.

The age of feminism has taught us that women should rise above their oppression and be free to prosper and to develop themselves in the workforce, on equal terms with men. The infant mortality rate has fallen, women have been living longer lives, and economic changes have made it desirable and often necessary for women to work. Many women have become economically successful and have proven that they can accomplish anything that men can accomplish, provided they are given the opportunity. They have achieved their independence.

It is this independence which is viewed as one of the essential ingredients in everyone's personal freedom, but the costs of this independence must be recognized. By definition, a family is established on the foundation of love and is bound together by commitments. These commitments are consciously accepted by each member of the family, and it these commitments which keep the family together. When one member of the family begins to stretch his/her independence to the point where fundamental commitments are broken, the family falls apart.

Deciding where the grey line between independence and detachment should be drawn is a personal matter, but today's high divorce rate and number of single parent homes, shows that the line is being crossed too many times by too many people. Perhaps the reason is that many people don't believe divorce is harmful or even worth being concerned with. Many

psychologists even try to justify divorce by claiming that it is better for the children rather than having them live in unhappy homes. It is true that a solution needs to be found for a child in an unhappy home, but divorce only perpetuates the problem. As Allan Bloom, professor on the Committee of Social Thought at the University of Chicago, writes: "to children, the voluntary separation of their parents is worse than death precisely because it is voluntary." Through divorce, children are taught that love and trust are never certain.

Unfortunately this is not the worst of what results from divorce. In all cases the result is greater poverty. For the majority of black "families" whose father has been absent since the time of conception, there is monetary poverty because the father is simply not available or willing to offer any money. The mother, who is unable to afford the cost of daycare, stays at home. This is the leading cause of poverty among blacks, and even the elimination of all racial discrimination can do nothing for this problem. For the majority of middle class whites who have suffered through divorce, the result is a poverty of time. The mother who can afford daycare spends her time pursuing a full-time career in order that she may offer "the best" for her children. As is turns out, the time she has with her children to enjoy the benefits of her hard work becomes sadly limited.

A remedy needs to be found to stop this cancerous trend in our society. If any cure is to be found it must begin within the family and between the parents. Both the father and mother must recognize their fundamental obligations to their children and consequently to themselves. This entails necessarily placing the family above all else,

Many parents will still claim to do this and yet both will be leading full-time careers during the first years of their child's life. This is an abandonment of their child and a relinquishing of the joys of parenting to the babysitter or daycare center. During the first years of a child's life he is in need of at least one of his parents at all times. When the choice needs to made between which of the two parents should fulfill this duty, the mother has the greater obligation.

After developing for nine months inside of his mother, a child is born and is immediately given to the mother's breast to nurse. It is an entirely natural attachment between mother and child. Not even the bottle can replace this relationship. The bottle only nominally satisfies the child's physical needs, it does nothing for a child's emotional demands. By asking the father to replace the mother during the child's first years is to break this most pure and natural bond between mother and child, replacing it with what is hoped to be an equally natural bond.

It is this failure to recognize the fundamental distinctions between the sexes which has led today's family into its sad state. In striving for their personal freedoms, parents need to redirect their ambitions towards the family because they may find that too much freedom and too little dependence can soon lead to poverty and solitude.







A Philosopher Awry

In 1974, the young Harvard philosopher Robert Nozick, created a stir with his first book Anarchy, State, and Utopia. In it he argued for a version of natural rights libertarianism, a view which had lately fallen into disrepute in serious philosophical circles. The claim was that only the minimal state was justified, the only legitimate function of government being to offer protection against force, theft, fraud, and so on. The State had no business using its coercive apparatus to force some of its citizens to aid others (for example, through redistributive taxation). Nor did it have any business forcing individuals to act or not to act in certain ways for their own good (for example, through anti-drug laws).

Nozick instantly became a hero to libertarians (while becoming sort of a curiosity in the philosophical community), and his book became one of the bibles of the libertarian movement. For a while, Nozick himself was actively involved in the movement, representing Massachusetts as one of the delegates to the 1976 Libertarian Party national Convention.

His second book Philosophical Explanations, published in 1981, was well received by philosophers, but was somewhat of a disappointment to those who expected a further defense or amplification of his views.

Was Nozick still committed to his earlier politics? There were signs that he was not. He published nothing further on political philosophy, and dropped out of the Libertarian Party. Then in 1986, The New Republic revealed that Nozick had recently taken his landlord to court for violating the Cambridge rent-control laws, certainly strange behavior for a libertarian.

With the publication of his third book the Examined Life (the rate of production here is precisely one every sevenand-a-half years), it's finally official: Robert Nozick has renounced libertarianism.

As somewhat of a libertarian myself, I suppose that I have a duty to dislike the book. But ideological consideration aside, disliking The Examined Life isn't too hard. Good philosophy it is not.

Indeed, one of the strange things about Nozick's political conversion (or reconversion-before Anarchy, State, and Utopia he was a socialist) is that the arguments he uses against libertarianism (if one can be so charitable as to call them arguments) are ones which the earlier Nozick would have had a field day either refuting or exposing as incoherent.

here is Nozick making the main claims:

The libertarian position I once pro-

inadequate, in part because it did not fully knot the humane considerations and joint activities it left room for cooperative more closely into its fabric. It neglected the symbolic importance of an official political concern with issues or problems, as a way of marking their importance or urgency, and hence of expressing, intensifying, channeling, encouraging, and validating our private actions and concems towards them... There are some things we choose to do together through government in solemn marking of our human solidarity, served by the fact that we do them together in this official fashion and often also by the content of the action itself... the libertarian view looked solely at the purpose of government, not at its meaning, hence, it took an unduly narrow view of purpose, too... the point is not simply to accomplish the particular purpose-that might be done through private contributions alone--or to get the others to pay too--that occur through stealing the necessary funds from them--but also to speak solemnly in everyone's name, in the name of society, about what it holds dear.

There are a number of possible interpretations of the above. On one interpretation, it;s not enough for say, 75 percent of society to make private contributions towards making sure that the homeless are all adequately fed, even if the goal of 75 percent of society--making sure that the homeless are all adequately fed--is realized through the private contributions. Rather, it is necessary for that 75 percent of society to force the other 25 percent (at the point of a gun) to contribute also. Thus the majority has the urgency of its concerns "validated". This is collectivism, at its rawest, and most ugly.

But Nozick rules out "stealing" the necessary funds, and later he writes "i think someone who conscientiously objects on moral grounds to the goals of and also my life." the goal here is apparently to meditate on "the important things in life" (also the title of the course Nozick teaches at Harvard.) but this is just a cover for Nozick to show us (O.K., let's get nasty) how good he is at saying something profound or clever on a wide range of issues only marginally related, the by now familiar flippant Nozickian prose begins to grate when it becomes clear that unlike Anarchy, State, and Utopia and Philosophical Explanations, the flippancy seems to exist for its own sake--there's no argument underneath.

To be fair, there are a few discussions of value, such as for example, the short meditation on the well known Problem of Evil (how could an all-good, all-powerful, all-knowing God allow there to be evil in the world?). But the valuable is outweighed by the just plain embarrassing. For example, in the chapter entitled "Sexuality" the following sentences occur:

The penis can be made to feel a welcome errant in the vagina; it can be kissed lovingly and unhurriedly; it can be made to feel nurturative; it can be delighted in and known for itself; in more exalted moments its fantasy is to be worshiped almost. Similarly, the sweetness and the power of the vagina can be ac-

knowledged in its own right, by tender kissing, long knowing, dwelling in the tiniest crevices and emitting those sounds this calls forth.

I find it impossible to read this with a straight face. (Perhaps this is my loss, who knows?) More to the point, I just cannot fathom the thought of Robert Nozick, author of two previous respected works of philosophy, past chairman of the Harvard Philosophy Department, and lecturer to graduate students and freshman alike, sitting at a desk writing with a straight face. How does Nozick think his readers will respond? With earnest, studious attention?

The transition of Nozick from respected libertarian analytical philosopher to collective new-age sex therapist, is now complete.

We note in conclusion that during the writing of The Examined Life Nozick was supported in part by a grant from the National Endowment for the Humanities. Let us rejoice that by taking money from the poor and giving it to tenured Harvard professors we may all jointly and symbolically affirm the value of philosophy.

But why not? What if someone objected on moral grounds to all of the policies that their government was funding through taxation? Or what of someone objected on moral grounds to the idea of coercive taxation in the first place? those individuals would then be subject to coercive taxation ("stealing"?). What is it about that state of affairs (the addition of coercion) which would allow us to "mark our human solidarity" or enable society to "speak in everyone's name"? What is it about that state of affairs which would be so noble?

Politics is only one of the topics which Nozick tackles in The Examined Life, the book begins with a declaration: "I want to think about living and what is important in life, to clarify my thinking--

O'Rourke's writings have won him political acclaim for his insights into world politics and his ability to find humor in the strangest places. The Wall Street Journal has even gone so far as to call him "the funniest writer in America."

P.J.'s popularity was evident when he spoke on October twenty-fourth at the Boston Public Library's Rabb Room which was filled to capacity by a crowd of four hundred fans. 

3. In June of 1975, U.S. Army Colonel Ernest Morgan was kidnapped by the PFLP.

4. Two members of the PFLP, in conjunction with the Japanese Red Army, unsuccessfully attempted to destroy a Shell oil refinery in Singapore on January 31, 1974. Seven days later, five PFLP members invaded the Japanese embassy in Kuwait, and held twelve hostages. The terrorists demanded that a plane be flown to Singapore to help their comrades.

PLO terrorists hijacked a Lufthansa jet to South Yemen on the twenty-second of February, 1972.

6. On September 5, 1972, a Black September squad murdered eleven Israeli athletes in the Olympic village in Munich.

7. On October 29, 1972, two Black September terrorists hijacked a Lufthansa jet, demanding the release of those murderers still alive following the Munich massacre.

8. A time bomb planted by George Habash's Popular Front, another PLO faction, was discovered in Berlin's Jewish Community Center on November 9, 1969.

9. 26 people were injured when a bomb planted by Sa'iga (a PLO artillery unit) exploded in a Jewish restaurant in Paris in March of 1979.

11. Abu Nidal terrorists attacked a synagogue in Vienna with hand grenades and sub-machine guns on August 29, 1981. Two people were killed and four were wounded.

Now we come to the issue of possibly letting PLO Chairman Yassir Arafat into the United States at any future time. I say yes, we should let Arafat into the United States, and handcuff him as soon as he steps off the plane. His arrest would be in perfect accordance with the U.N. draft resolution which reads:

The General Assembly...calls upon all States urgently...to deter and prevent acts of international terrorism and to take effective measures to deal with those who perpetrate such acts...and to prosecute and punish those perpetrating such acts...

Some have suggested that those factions of the PLO committing terrorist acts have, in fact, no connection to Arafat. If that's the case, then the U.S. has no reason to be conducting talks with the 10. Three Fatah members and two PLO, for Arafat's so-called "renunciation"

of terrorism simply means that Arafat himself won't shoot or kidnap anyone. Therefore, Arafat has no business at the U.N., for he isn't truly in control of the PLO, nor does he represent the Palestinian people. On the other hand, if he is in control of the PLO, then no terrorist act by a PLO faction can be considered unrelated to Arafat. In any case, he's got no business

Even if one were to suggest that the attacks by the PLO on Western targets were not terrorism, but attacks on symbols of oppression by freedom fighters (try that one out on the families of Robert Stethem, Leon Klinghoffer, or William Higgins), that still does not excuse the war crimes of the PLO committed against the Lebanese people. I suggest that Yassir Arafat be barred from entering the United States indefinitely.

For war crimes of 45 years ago, Kurt Waldheim is presently barred from entering the United States; the same ought to apply to Arafat and the PLO's war crimes of a mere decade ago, not to mention the ongoing acts of terror against American interests and allies.

Don't Blame It On Us

Racism: Hatred or intolerance of another's race or other races (Random House Dictionary)

The trend that has developed among many minority communities nationwide is to blame growing racial tension on "white" society. On this campus, popular thought takes an additional twist. Here conventional wisdom often dictates that the people who incite racial problems are "conservatives" -- namely members of The Primary Source. Many here often misinterpret attacks on the inconsistencies in the administration's "diversity policy" as unwarranted attacks on innocent minorities. The idea that conservatives condone or intentionally "promulgate" racism is factually unfounded. I hope to show that the preponderance of the apparent increase in racial tension can be attributed to three groups: The residents of surrounding towns, the minority activist groups, and most of all to the administration itself.

The first spreaders of racism are angry local juveniles who often come to our campus on occasional weekend evenings. This is not to say that all neighborhood youth are bad, but certain negative elements like to assault random students. terrorize Tuftonia's women, and howl racial epithets through their car windows. Many on campus try to pin these attacks on conservatives. The fact of the matter is that the perpetrators of the majority of the racial crimes are not Tufts students who are unenlightened and full of spite.

The second instigators of racial tension are overzealous activists among the members of certain "oppressed groups." The defensiveness of these groups causes them to see race as the only rationale for conflicts between members of different races. These people will often interpret some wrongdoing to them as a racial attack for the sole reason that the "attacker" belongs to a different racial group. There is no denying that cases of racial wrongdoing exist, but a plethora of cases have occurred where racism was misrepresented as the cause of conflict. A recent example happened in the Math Department.

A Jewish student claimed that the Math Department practices an anti-Semitic policy because they would not reschedule a test from the time surrounding the Jewish high holidays to another day. If the student practiced her religion, she would not be allowed to study because the day before the test was Yom Kippur. From the sound of the complaint, one would think the KKK creates departmental policy. It turned out that the student left much information out of her statement -- she knew the date of the test months ahead and could have prepared her study schedule around it. The reason she could not make up the exam had nothing to do with anti-Semitism. In fact, the faculty member whom the student accused is Jewish himself. This fact is irrelevant though. Even if he were an Irish Catholic conservative, his identity would not make him guilty of racism.

Another example which occured last year had to do with the Safety Shuttle. A young black woman accused a Safety Shuttle driver of being a racist because he would not drop her off until he first delivered some white students even though the black woman had boarded first. On the surface, this looked like blatant discrimination. It turned out that the girl was mistaken. The driver had picked her up on the street, en route to a scheduled pick up, and standing shuttle policy is to deliver scheduled passengers before non-scheduled ones; not whites before blacks.

If the administration stopped here, a campus where racism of any degree is they would simply be misguided, but they extirpated. This is a truly noble cause; all sink to the level of the malevolent. When educated people with any sense of justice organized groups criticize their methods as being unconstitutional, the administration rationalizes this to racism. "Logic" tells the administration that such groups criticize them because they want to freely harass minorities. It is analogous to Mc-Carthyism. Combatting Racism

The recent polarization of opinion on racism here at Tufts has made me ponder the issue considerably. Because I am associated with the Primary Source and the conservative side of things, I was most troubled by the recent outlash against the Source.

First, let me say that I am a white male. My perspective may be blurred because I may be a benefactor of a whitedominated society, and I may not understand the pain and outrage of minority communities, but I am still human, and I understand basic human needs and goals equality, freedom, and justice. These ideals are not white ideals. They are universal. It is true that in America whites have manipulated these societal goals to suit themselves, often in an outrageous manner slavery, the principle of separate but equal, and general social discrimination - but all the same these ideals are universal; they are the end goal.

So, how do we go about achieving these ideals? Certainly racism helps to in order to destroy it.

prevent the realization of these ideals. Thus the elimination of racism must be a goal of our society. Let us use the definition of racism used frequently in many of the campus media: power + prejudice = racism. This is a questionable definition to begin with because many would argue that racism has nothing to do with power, rather, it is the belief that some races are superior to others, causing the subsequent discrimination based on that belief. These individuals would argue that power does not enter into the equation at all. However, I accept this definition of racism if we remove its ambiguity by prefixing prejudice with racial. Thus: power + racial prejudice = racism. With this minor change, which I am certain few would dispute, I accept the definition.

Racism as defined here is certainly a huge problem. The vast majority of people in power in America are white, and certainly significant numbers of these whites are prejudiced against minorities. Thus racism is prevalent. Therefore it is important to find the source of this racism

Of power and prejudice, which concept causes racism? of power and racial prejudice, which is the evil? Many would argue that power is the evil, for it allows the strong to discriminate against the weak. However, those in power will try to maintain power. One may argue over whether this is good or bad, or whether we can even do something about it, but that is not the concern of this essay. Targue simply, that once you remove prejudice from the equation and leave only power, discrimination based on nothing other than the maintenance of power remains. Thus, power without prejudice is not linked to

In consequence, the part of the equation relevant to racism and the eradication of racism is the factor of racial prejudice. If those who are in power have racial prejudices, they will try to restrain the development of those whom they are prejudiced against. Thus, if you eliminate racial prejudice, you eliminate racism, and

Racial Injustice

Looking out his dormitory window, Tom saw a friend, Mike walking up the side walk. Mike was wearing a bandanna around his head. Instantly, Tom made the connection to Aunt Jemima, the character on syrup bottles and pancake mix boxes who wears a bandanna. As James, Tom's roommate, joined Tom at the window, Tom yelled out the window, "Hey, Aunt Jemima!" James followed the thought through with, "Nice hat!"

Across the quad a black student, Jen, overheard this exchange, and would soon drag Tom and James into a very unexpected and unwanted situation. Although the names have been changed to protect all those involved, this incident did occur on Tufts University's Medford campus. Jen had no legitimate reason to be offended, but because of her complaint Tom was tried under Tuft University's racial harassment policy and unfairly placed on probation level I.

Why was Jen offended by the public reference to Aunt Jemima? In an open forum in an English 001 class on the Tufts campus, one student reminded the others. "Aunt Jemima has black connotations". Aunt Jemima is a black character that sells syrup and pancake mix. Being a black character, Aunt Jemima most certainly does have black connotations.

Certainly a phrase is not offensive merely because it refers to blacks. If this is true of Jen, she lacks a fundamental pride in her race and herself. As a black student noted, although there are terms that refer to blacks and are offensive, these terms are separated from those like "Aunt Jemima" by the meaning behind them. Aunt Jemima has no hidden meetings. She merely sells syrup. In fact her position as the symbol of a successful company indicates the public does not find her offensive.

However, people can warp the meaning of words. Calling a black child boy will not offend him like it would offend a grown black man. Again the word "boy" is not an evil word. However when someone calls a black man boy, the word comes with a derogatory intent. Did Tom say, "Aunt Jemima" with a derogatory intent?

After the incident took place, Jen talked to her R.A. about it. Later, Jen's R.A. told Tom and James they had offended someone. Tom and James explained they had not intended to offend anyone. They told Jen's R.A. the comment was directed at one of their friends, not at Jen. Tom explained he was merely making fun of his friend's strange (to Tom) choice of dress. In fact, they had been unaware of Jen's presence at the time. But, they were still sorry they had offended Jen, and offered to apologize immediately. Coming before any threat of disciplinary action, this offer demonstrated Tom and James' sincerity. They never intended to be derogatory.

Tom and James were finally brought together with Jen in a meeting with Associate Dean of Students Reitman. During this meeting they apologized to Jen. At the meetings conclusion Reitman said it was Jen's decision to press charges if she felt it necessary. The apology meant nothing to Jen. She pressed charges.

The offense Jen felt did not come from the words themselves; "Aunt Jemima" is not offensive. It did not come from Tom or James. Not only was the comment not directed at Jen, but it was not intended to offend anyone. Additionally, a black student observed that if Tom and James "wanted to use a derogatory [term], they could have thought of something better [more offensive]." The elimination of the phrase itself, Tom, and James leaves only one possible source of offensiveness remaining, Jen. Jen placed the derogatory connotations on "Aunt Jemima" herself,

Jen's R.A. definitely made it clear to Tom and James that one must be careful what one yells out one's window as it might offend someone. In "How to handle a Racist", an article in Ebony magazine, Mervin Aubespin, president of the National Association of Black Journalists recommends a victim of racism on the job should try to resolve the problem with the offender verbally. If unable to do so one should then take the problem to a supervisor. (Ebony, November, 1984, "How to handle a Racist" p.54) Taking this attitude in her case, Jen should have been happy with getting her message across and dropped

Jen should not have felt slighted because the remarks were not directed at her, were not offensive, and were not intended to offend. However, she did feel offended. In Ebony, experts "emphasize that though you may be the victim of a racial slur or slight, that in no way diminishes who and what you are. Self-esteem and racial

pride...are important weapons in fighting racism..." (Ebony, p.52) Jen should not have let Tom's comments damage her self-esteem or racial pride. Jen did not pursue the issue further to reach Tom or James: she had done that. She pursued the issue because she was vengeful for the damage done to her self-esteem. When Jen filed a complaint of racial harassment she did not act as she should have,

The University's harassment policy as detailed in the Pachyderm defines racial harassment as a subjection "...to ridicule, threats, repeated annoying acts or other forms of harassment because of...[one's]...race..." (1989 Pachyderm,

While Tom and James were ridiculing Mike's hat, they were definitely not ridiculing Jen; they were actually unaware of her presence, henceforth not directing their comments to her. "Hey, Aunt Jemima, nice hat!" is not a threat. It implies no further action and lists no conditions. And while Jen found it annoying (unjustly so) it was not a repeated act.

The Pachyderm's reference to "...other forms of harassment..." is at best misleading. As harassment is simply persistent annoyance (Webster's Ninth New Collegiate Dictionary, Merriam-Webster, 1988 p.552), this is a restatement of, "...repeated annoying acts..." (1989 Pachyderm, p.47) This is an error of redundancy. Tom and James are Victims of Tufts policy even more so than victims of Jen's vindictiveness.

"The aim of this policy is to inform everyone of the standards of the community and thereby avoid violations." (1989 Pachyderm, p.49) Tom and James were not guilty of harassment as defined in the Pachyderm, and as the Pachyderm is the self-confessed informant of policy, they were not guilty of violating any policy which they were supposed to know about.

Associate Dean of Students Bruce Reitman explained Tom's probation in the Thursday, October 12 issue of the Tufts

"Although the panel didn't find evidence to support the accusation that the student intended to offend the woman, panel members nevertheless decided that he still had no right to make his remark a public one by shouting out the window and not knowing who might hear it and be offended or hurt."

According to Reitman the students were disciplined for not knowing what to say, or when to say it. The University's harassment policy does not mention this as a



violation at all. Since the repeal of the speech policy, no other University policy deals with this issue. Tom was punished without violating any University policies.

Although Tom was not guilty of any violation, the University did punish him. The Pachyderm sets an outline for determining the consequences of violating policy, which vary from warnings to expulsion. The first factor in the outline is "How great was the potential harm, emotional or physical, to the victim? How intimidating was the incident? Were several people involved in the planning of or actual harassment?" (1989 Pachyderm, p.49) Not even Jen can accuse Tom of intimidation or potential physical harm from his remote upper floor window across the quad. It's difficult to believe that being compared to a syrup lady could crush one's confidence level. Additionally the incident was un-

The other factors involved in the sentencing of offenders are, "To what extent should the individual(s) responsible for the offense have anticipated the potential harm to the victim(s)? Did the offense include an element of threat so that the victim felt justifiably menaced physically? Was this a first offense of the person(s) involved?" (1989 Pachyderm, p.50)

There was no way for Tom to predict the potential harm to Jen because not only was he unaware of her presence, but he did not think the phrase, "Aunt Jemima", would offend anyone. From his window on the opposite side of the quad Tom was not in the position to physically menace even the meekest of people. And Tom has no prior offenses.

If the University had followed the policy it sets in the Pachyderm, Tom's punishment would surely have been the lightest available (a warning), if he had been punished at all. By placing Tom on probation, rather that giving him a warning, the University strayed from its own policy. Tom did not violate any facet of the racial harassment policy. Tom did not fulfill a single section of the University's outline of consequences. The University let Jen's vengefulness be Tom's judge and juror, almost completely ignoring University policy. Rather than protect Tom from an accusation, the University's policies were reviewed off-handedly as an innocent man was punished.




