 16 because an individual worker is a worker of legal agricultural

1 (2) This section shall not prohibit an employer from
 2 offering services or benefits to a family, disability,
 3 or life insurance holder which under circumstances before the
 4 employee for any of reasons or terms of service based upon
 5 the employee's use of legal agricultural products provided
 6 that:

7 (a) The plan or benefit is Federal Government under
 8 the employee retirement income security act (ERISA) or any
 9 other federal law which is not subject to employee and family
 10 discrimination rules by the employer or insurance; and
 11 (b) The employee and family member with a
 12 substantial disability the discriminatory rules used by the
 13 insurance carrier.

14 Section 2. This act shall take effect upon becoming a
